

Health & Safety Agreement for Galveston Ballet

The health and safety of our community is our highest priority. For the safety of Galveston Ballet's members, students and staff, the following rules will be enforced due to the COVID-19 virus pandemic. Please review and sign upon returning to Galveston Ballet. We expect that each member agrees to the following:

- Students and Staff are expected to monitor themselves for symptoms of COVID-19.
- No one is permitted to enter the studio for any reason other than Students, Staff and Board Members.
- Parents/Guardians are to wait outside the studio to pick-up and drop off students.
- Face coverings and masks are optional. This will allow parents/legal guardians/adult students to decide what is best for their child/themselves. All GB staff are all fully vaccinated.
- Hand sanitizer will be required and provided at a sanitation station as students enter/exit the studio.
- Temperatures will be scanned of everyone upon entering the studio.
- Students are required to bring their own labeled water bottles. Plastic cups will no longer be provided at the water cooler to avoid spread of germs. No other food or drink allowed in the studio.
- The upstairs dressing rooms and stairwell will be off limits to all students at this time including upper company level and alumni students.
- The studio will no longer have a 'lost and found' basket for holding personal belongings left behind. We will dispose any items left behind. Please make sure all belongings are gathered after class.
- If a student is experiencing any symptoms of illness during class, parents and guardians will be immediately notified and will need to pick up the student.
- Parents/Guardians will be notified immediately if a COVID-19 case is suspected in their student's class level.
- Please carefully read all updates and emails for information and important safety notifications.

If you or someone in your household has been exposed to the COVID-19 virus, please notify Galveston Ballet's Artistic Director, Janel Amsellem immediately at 409-599-6514. Please stay home and refrain from attending class until evaluated and a clearance letter to return is provided by a physician. All reports will be kept confidential.
